

GIFT ANNUITIES



You have succeeded. Now your contribution will improve the health of future generations.

A charitable gift annuity allows you to make a gift to CAPPED that will help in our mission of primary cancer prevention, early detection and family support – and, at the same time, plan for your financial future.

A gift annuity is a simple contract between you and CAPPED in which you exchange cash or securities for fixed payments for life – for any person you choose. You can have payments begin this year or postpone any payout until a future time, such as retirement.

How much could a CAPPED Gift Annuity Pay You?

Just send us a note with your name, mailing address and phone number and we will give you that answer!

An example:

Suppose John, age 76, has \$10,000 in a CD that will mature next month. He thinks he can get 6% interest on a new CD, but John has been thinking of leaving \$10,000 to CAPPED and that leads him to a better plan:

1. Annual payments of \$800, of which \$478 will be tax-free for the next 11.9 years*;
2. An income tax charitable deduction of about \$4,356 (deductions fluctuate every month according to federal interest rates); and

The immediate satisfaction of assisting the many worthwhile programs of CAPPED.

Note that the charitable deduction is available to donors who “itemize” deductions and in some cases may not be wholly deductible in one year. Excess deductions, however, can be carried over and deducted for five years.

Joint and survivor annuities make sense. Gift annuities can be arranged to provide payments for the lifetimes of two people, such as a husband and wife. Two-life gift annuities also provide charitable deductions and payments that are partly tax-free.
